### P.C. PUBLIC SCHOOL PARTNERSHIPS Four New Partnerships Active At Elementary, Middle Schools

Over the past year, law firms have launched busy partnerships at four D.C. public schools. Last fall, **Brown Rudnick** had a successful winter clothing drive for every grade at its partner school, Whittier Education Center. The firm collected coats and other warm clothing for students in every grade from pre-K to sixth grade. This spring, volunteers from the firm took students on a tour of the Capitol. Plans for the coming school year include bringing Whittier students to the firm for a tour, lunch, and a variety of other activities.

The tutoring effort that **Dow Lohnes** began at Kelly Miller Middle School will continue during summer school. Revamping the school library is at the top of the firm's to-do list for the school. Now it has been transformed to pre-K-8. **Drinker, Biddle & Reath** launched a partnership with Anne Beers Elementary School located in far Southeast Washington. **Brown Rudnick** began an energetic partnership with Whittier Education Center, another pre-K-8 school. **Dow Lohnes** is busily working with the students at Kelly Miller Middle School.

Public Schools to know that there is a caring community that wants them to succeed. This will be my last column. Several years ago, **Akin Gump Strauss Hauer** & Feld established the not-for-profit Akin Gump School Partnership Project to support and fund its long-standing partnership with the John Tyler Elementary School in Southeast Washington.

Stan Samorajczyk founded and presided over the Partnership for over a decade until his retirement from Akin Gump in 2008, after which I became President.

Anchoring the partnership during Stan's tenure and continuing today is the tutoring program, which matches Akin Gump personnel with Tyler students in need of additional academic help. Tyler Principal Terry Dade reports that the tutoring program has helped students improve their school work and performance on the District of Columbia annual achievement tests.

Among the many other Tyler initiatives to which Akin Gump personnel have volunteered and contributed financially are: a major library renovation project completed in 2007; academic and summer enrichment scholarships; transportation for student field trips; catering for backto-school and parent-teacher conference nights; and an annual holiday party, fun fair and other special events for students.

The Partnership is currently assisting Tyler community volunteers with construction of an outdoor classroom, which will feature natural habitats to enable hands-on ecological and environmental learning for Tyler students on campus.

The Partnership is helping raise and manage funds for the project and regularly participates with the project sponsors, the D.C. Office of Public Education Facilities Modernization, and grantors to the project to oversee its execution. Akin Gump volunteers also have helped with initial tree and flower plantings for the project.

Additionally, Akin Gump's 2009 Summer Associate class will teach a day-long financial literacy lesson to Tyler students in June through a program sponsored by Junior Achievement of the National Capital Area.

Akin Gump has also continued to host the Washington Lawyers' Committee's partnership lunch meetings.

These three meetings per year, to which all partnership coordinators are invited, have given me and others at the firm an opportunity to learn about the activities of other school partnerships, and to benefit from working with the Committee and Iris Toyer, who has done a wonderful job of directing the school partnership project. ### Six Law Firms Win Top Taste-Off Prizes

Joan Nathan is the author of award-winning cookbooks and the host of the acclaimed PBS series Jewish Cooking in America. She is an internationally recognized expert on food culture and a 2001 inductee into Who's Who of Food and Beverage in America by the James Beard Foundation.

First place in the pie category went to Kate Wersinger from **Steptoe & Johnson** for her classic apple pie. Close second- and third-place winners in that category were pecan pie tartlets by Andrew McLain from **Bracewell & Giuliani**, and coconut custard pie by Alida Barleta from **Fried, Frank, Harris, Shriver & Jacobson**.

Steptoe also took top honors in the cake category with Kim Treadwell's carrot cake. Second- and third-place cake winners were the pineapple upside-down cake baked by Cynthia Simpson from **Akin**, **Gump, Strauss, Hauer & Feld**, and the nuttin' apple cake baked by Rosita Williams from **Bracewell & Giuliani**.

A team of young geography whizzes from J.O. Wilson Elementary School swept the 4th Annual GeoPlunge Geography Tournament at Columbia Heights Education Center (formerly Bell Multicultural High School) to give the school its second straight GeoPlunge Championship last Friday.

The winning J.O. Wilson trio prevailed over 47 other teams from nearly 40 D.C. public schools and earned the right to display the GeoPlunge Championship Cup at their school for another year. The defending champs defeated Eaton Elementary in a thrilling final. Tubman Elementary finished third, with Seaton Elementary taking fourth to round out the top four.

GeoPlunge is an award-winning set of geography games created by **Arent Fox** attorney Alan Fishel. The Washington Lawyers' Committee and D.C. Public Schools, along with Arent Fox, organize the annual tournament, which is sponsored by dozens of local law firms and businesses.

Nearly 150 fourth- fifth- and sixth-grade students from across Washington, D.C., competed on their schools' teams in this year's tournament, which was opened by D.C. Public Schools Chancellor Michelle Rhee, who welcomed the students at the start of the competition.

The course was so popular that parents of Marie Reed students have also expressed interest in taking the financial literacy class. Fannie Mae instructors are now looking into offering the course to Marie Reed parents as well.

#### Creativity, History, and Fun Come Together In Arent Fox's Landmark Arts Project

The Landmark Arts Project that **Arent Fox** brought to Randle Highlands Elementary School made it possible for students to learn history while having fun and expressing their creativity. Each class at the school was assigned a Washington landmark.

Pre-K and kindergarten students had the White House; first-graders had the Washington Monument; second-graders were assigned the Frederick Douglass' home and National Historic Site; third-graders had Mary McLeod Bethune's home and Council House; fourth-graders were given Union Station; fifth-graders had the U.S. Capitol; and sixth-graders were assigned the Supreme Court.

After the landmarks were assigned, attorneys and staff from Arent Fox visited each classroom at Randle Highlands and taught a lesson about the landmark assigned to that class.

Attorney Marcia Durkin, for example, along with another volunteer from the firm taught three first-grade classes about the Washington Monument and its namesake, George Washington, using photographs and interactive exercises to engage the students.

In one exercise, called Fib or Fact, students learned historical facts about George Washington, and that what one hears about famous people is not always true. Thirty volunteers from the firm took part in the teaching phase at Randle Highlands.

At the conclusion of the landmark classes, the students created art work about the landmarks. The artwork was then displayed in one of the firm's conference rooms. At Arent Fox, attorneys and staff voted on the best artwork. The three winners from each grade came to a pizza party at the firm. During the party, students and Arent Fox volunteers watched a slide show of the winning pictures.

#### Akin Gump Helps Make Outdoor Classroom Reality for Tyler

Akin, Gump, Strauss, Hauer & Feld is proud of its support of Tyler Elementary School, whose students have shown remarkable improvement over the past decade. The firm's tutoring program and support for teacher training helped to raise students' test scores. The internet wiring and library makeover that Akin Gump brought to the school is an important contribution to its positive learning environment.

These days, the firm is excited about its involvement in a project that will transform an acre of asphalt behind the school into an outdoor classroom.

The official name of the effort is School Yard Project: Urban Learning through Outdoor Play, Sustainability and Watershed Protection. After it was conceived by a group of parents, some of whom had architecture and urban planning experience, it was warmly embraced by the school administration and faculty and by Akin Gump.

The firm set up a nonprofit organization that made it possible for the parents to raise over \$160,000. Their nonprofit organization was awarded three major grants totaling \$140,000, and they raised an additional \$20,000 to \$30,000 in small grants and donations. They also succeeded in securing such valuable in-kind donations as the demolition and removal of the asphalt and new playground equipment.

Charlie Johnson from Akin Gump is working closely with the parents to make sure their nonprofit organization is complying with the legal requirements of the grants. Erika Lehman, one of the project's key parents, says, "I don't know what we would do without him. He makes it possible for us to come up with the necessary documentation to be in compliance with these grants."

The project got underway last fall with the planting of new trees and plants along what will be one of the borders of the outdoor classroom. This

summer the asphalt will be removed, and a green playground for young children will be installed. Planting will be resumed in the fall and will continue for several years.

Tyler's School Yard project has been endorsed by the school system, the National Wildlife Federation, the Anacostia Watershed Society, the U.S. Environmental Protection Agency, and Ward 6 D.C. Councilmember Tommy Wells.

#### Steptoe & Johnson Helps Scott Montgomery With School Play

In May, **Steptoe & Johnson** helped Scott Montgomery Elementary School present a performance of Pinocchio for school parents, neighbors, and others from the community.

Volunteers from the firm helped with costumes, make-up, props, and many other tasks involved in putting on the play.

#### Beveridge & Diamond Brings New Library To Birney Elementary

Improving the environment is a dominant theme in the partnership between the law firm of **Beveridge & Diamond** and Birney Elementary School. Ten years ago, attorneys in the firm's environmental practice launched an environmental course that teaches students about pollution and how to reduce it. A couple of years ago, the firm undertook a library renovation project that brought improvements to both the physical and academic environments in the school.

Birney had no library, but on the second floor was a dusty, good-sized room that for at least five years had served as a glorified closet. Extensive cleaning and painting by volunteers from Beveridge and Diamond transformed the grimy storage area into a bright space for the school library. The school's principal, Charles Webb, was particularly impressed with the effort that managing, partner, Ben Wilson, put into painting the library space. According to the principal, the law firm is an invaluable resource for the school in many ways.

To help stock the new library, Beveridge & Diamond had a holiday gift drive, during which employees at the firm gave books as well as money for books and other library materials.

Local school dollars, federal funds, and a donation from Toyota also helped to stock the library.

Jean DeLeon, a school volunteer, who had tutored many children at the school, had a feel for the kinds of books that would interest Birney students, and she provided valuable guidance in developing the library collection. For example, she perceived that Birney students are especially fascinated by snakes. And today, the library's books in greatest demand are those about snakes.

This past school year, students from Savoy Elementary School are also going to school in the Birney school building, because Savoy is being renovated. These students are already benefiting from Birney's library collection. This summer, Birney will be closed. Next fall, Birney students, along with the school's library collection, will go to Savoy, and Beveridge and Diamond's new school partner will be Savoy Elementary School.

#### Variety of Fried Frank Efforts Promote Literacy At School Without Walls

Even though the School Without Walls is one of the area's highest-achieving schools, supporting literacy at the school is an important tradition for its partner firm, **Fried**, **Frank**, **Harris**, **Shriver & Jacobson**.

Every year, the faculty at Walls, as the school is often called, recognizes students who read 25 books or more on the school's reading list. The reading list is tweaked every summer to accommodate new books. It includes fiction and non-fiction as well as classics and contemporary books.

For the past nine years, the students have received their reading awards during a late spring event at the firm. This annual program at Fried Frank has grown from an occasion for recognizing the school's avid readers into an impressive event.

The school now uses it to make all of its endof-the-year awards and to recognize graduating seniors who have received scholarships. Immediately after the awards program, the firm also hosts a reception for the Walls students and their teachers and parents. This year, Fried Frank will be giving the students gift cards.

Fried Frank also supports literacy at Walls with book drives and by reading senior papers. Recently, attorneys and staff brought used books to the firm. After the school librarian selected the books that could be used at Walls, the firm had a used book sale with the remaining books. The proceeds of the sale were given to the school to buy books on its wish list.

One way the School Without Walls works to develop a high degree of literacy in its students is by requiring them to do a significant amount of writing that includes a senior research paper. Fried Frank supports student writing by helping the teachers grade the senior research papers.

#### Fannie Mae, Law Firms Provide Books For Schools

For the past three years, **Fannie Mae's Legal Department** has teamed up with the D.C. bookstore Politics and Prose to conduct a book drive for the Marie Reed Learning Center.

Twenty percent of all purchases made at the store over a three-day period that includes a weekend are donated to a Marie Reed book fund.

The book drive, which occurs in the fall during the holiday shopping season, is widely publicized throughout Fannie Mae. Employees are encouraged to buy their gifts at Politics & Prose and to buy books on the school's wish list during the drive. Fannie Mae employees are also encouraged to bring in gently used books to support Marie Reed's efforts to provide books to the families of children who attend the school.

Last fall, **Steptoe & Johnson** also partnered with Politics & Prose in its book drive for Scott Montgomery Elementary School. Steptoe's book drive raised \$3,000.

Other high schools recognized for their outstanding legal presentations this year were Banneker, coached by **Arent Fox;** Cardozo, coached by **Covington & Burling**; and Dunbar, coached by **Williams & Connolly**.

The coordinator of the Williams & Connolly coaching team, Amer Ahmed, has also developed a series of interactive constitutional law lessons for Dunbar students. These lessons explore freedom of speech, freedom of association, and other fundamental rights.

**Drinker, Biddle & Reath** launched its partnership at Anne Beers Elementary School with a tutoring program that involves 25 volunteers from the firm. Drinker Biddle is working with the Principal, Gwendolyn Payton, to get permission to continue tutoring students over the summer. The firm is also looking forward to working on fix-up projects at the school. **Epstein, Becker & Green** (EBG) is very busy at Emery Educational Center. The firm arranged for students at the school to take part in the Breakfast with a Legend sponsored by Street Law, Inc. Through that program, Emery students enjoyed three breakfasts with federal judges from the D.C. Circuit. Prior to the breakfasts, the students were prepared during three classroom sessions conducted by volunteer attorneys from the firm. Through a variety of fundraising efforts, EBG raised enough money to make it possible for every student who does well on standardized tests to open a \$25 savings account.

Last year, Bracewell & Giuliani turned no-longer used equipment and office furniture into classroom and playground equipment for Brightwood.

The firm sold its older, but useful office equipment and furniture during a fall garage sale, raising \$600.

The funds were used to purchase large bags of balls and other playground equipment which Bracewell presented to each class at Brightwood.
