9th City-wide GeoPlunge Contest Set for November 14 At National **Portrait Gallery**

DC's 9th city-wide GeoPlunge Challenge Tournament will be held on November 14 from 9:00am to 2:45pm at the Smithsonian's National Portrait Gallery on the corner of 7th and F Streets, NW, Washington, DC. Three-person teams will be welcomed from all DC public elementary and middle schools. The Committee's Public School Partnership Program, Arent Fox, and the DC Public Schools are sponsoring the tournament. The Committee is also actively recruiting coaches and sponsors for GeoPlunge teams from individual schools. This year, a record number of firms are involved in coaching teams for the tournament, and a record number of teams are expected to compete. Over 50 team sponsors are needed for this year's tournament.

GeoPlunge is an award-winning set of geography games created by Arent Fox attorney Alan Fishel. As one student describes it, "GeoPlunge is a very educational game. It helps you with a lot of things you should learn-border states, capitals, top citieseverything you want to know about cities and states."

On November 18, the Washington Lawyers' Committee's 3rd Annual Celebration of Song will again benefit the School Partnership Project. This year's event, which will commemorate the 1963 Civil Rights March on Washington, will take place at 6:30pm at Theatre J, DC Jewish Community Center, 1529 16th Street, NW, Washington, DC.

As in past years, the benefit will include wonderful music and a raffle featuring spectacular prizes. Peter Yarrow, the Washington Revels Jubilee Voices, and the choir from one of our school partners, The School Without Walls Choir, will perform songs inspired by movements for social justice. Peter Yarrow's most recent Washington appearance was this past August at the 50th Commemoration of the 1963 March on Washington. At the Commemoration, he performed the song "Blowin' in the Wind," an anthem of the civil rights movement, that his acclaimed folk group-Peter, Paul, and Mary—performed at the Lincoln Memorial during the original 1963 March on Washington. Peter Yarrow has also developed an anti-school violence campaign and curriculum.

This will be a busy Fall for our School Partnership Program. I am happy to report that our School Partnership team has expanded. The longstanding partnership between **Fried**, **Frank, Harris, Shriver & Jacobson** and the School Without Walls began in about 1989 when we teamed up for the Street Law class. We concentrated on the Mock Trial Tournament in particular during those early years, often placing at least one team in the city-wide finals. In one memorable year, a first-place win led to a trip to Madison, WI, where students were able to compete in the national tournament.

Beginning in 1997, when the Washington Lawyers' Committee began promoting school partnerships widely, Fried Frank decided immediately to broaden its participation with the School Without Walls rather than add a partnership with a different school to its Mock Trial work.

Over the years, the partnership has expanded to a variety of other activities. Some, such as tutoring or writing workshops, have been requested by the teachers while others, including a weekly Current Events Roundtable, were created by our volunteer lawyers.

We have also taught individual classes; contributed speakers for Career Day; presented an architectural walking tour; participated in a program about jury duty; graded papers and judged presentations for Senior Project; taught an SAT prep class; given book awards for reading achievement; and hosted trips to local courts or historic sites including Mount Vernon, Gettysburg, Williamsburg, and Philadelphia.

Just last year, we provided mentors for the newly formed Bridge class, designed to assist students in building math and reasoning skills. We've also helped the school with fundraising for enrichment activities through book sales and participation in the Committee's annual Bake Sale and Bake-Off competition.

Calling GeoPlunge Teams, Coaches and Sponsors For 9th City-Wide Tournament (cont'd)

The geography games are played with a set of cards, each representing one of the 50 states. The tournament will include three different card games that combine geography and fun. *Guess the State* encourages students to learn the names of the 50 states. Playing *Race for the Borders* teaches participants where states are located geographically. When students *Play the Ranks*, they learn how the states rank in size, population and order of entry into the union.

This school year will be a busy one for young geographers. In addition to the November city-wide competition, there will be a spring tournament in March or April sponsored by the Washington Redskins Foundation. It will be held at the foundation's indoor facility in Loudoun County, Virginia. The first national GeoPlunge tournament will take place on May 22 at the Portrait Gallery. The top four finishing teams from each division of the fall DCPS tournament will automatically qualify for the national tournament.

As in past tournaments, the competition in the 8th GeoPlunge Challenge tournament was fierce. Teams from Alice Deal Middle School and Shepherd Elementary School placed first, second and third in the tournament. The Comeback Prize for the team that made the greatest improvement during the afternoon competition was won by students from Langley Education Campus, who were coached by volunteers from **Epstein, Becker & Green**.

Growing Number of Firms Involved in GeoPlunge

Not only do many firms sponsor their partner school's GeoPlunge teams, a growing number are also becoming involved in preparing students for the tournament. **Beveridge & Diamond**, for example, conducts biweekly practice sessions for the teams from Savoy Elementary School. Laura Duvall took the lead in developing a study guide for these sessions. Each week, the focus is on a different section of the country and includes a drill on state characteristics. Students who excel in the drills earn rewards.

Goodwin Procter provides a summer GeoPlunge Camp for students from West Education Campus. The program or curriculum for the camp was developed by Goodwin Procter Associate John Raffetto, who is also a former teacher. The weekly camp featured games designed to teach students the basics of US Geography. After students went back to school in August, the firm's coaching sessions were shifted to the West Education Campus.

Communication is the Key to Rewarding Partnerships

Effective communication between law firm volunteers and school staff is essential for a successful partnership. Ways of getting and staying in touch have to be carefully worked out and should be reviewed as each new activity is launched. Communicating with your partner school will most likely require more effort than getting in touch with a colleague at another law firm.

Be aware that educators spend most of their day away from their computers. Keep in mind that, in many cases, working with you on the school partnership is a responsibility that has been added to an already heavy workload. It requires effort for a teacher to get to a phone or answer an e-mail and for an administrator to get back to you. Be understanding if it takes them longer than you are used to for them to return a message, and plan accordingly.

Figuring out the best way to reach your school contacts will make a difference. Be flexible by asking when and how best to reach them, and try to accommodate their schedules.

Creating and maintaining a good relationship with your school's principal is, of course, important. It is also helpful to have other direct contacts, especially for coordinating specific activities or events. When you are at the school, take time to introduce yourself to all those who work in the principal's office, and make sure they know about your firm's partnership with the school. These individuals can be very helpful in conveying your messages.

Finally, if you have persistent communication problems, contact the School Partnership Program, and we will help to get things back on track.

Ensuring a Smooth Transition To Your School's New Principal

Adjusting to a new principal can present a significant challenge to a school partnership. But as Charlie Johnson from **Akin Gump Strauss Hauer & Feld** will confirm, the transition to new school leadership need not be a barrier to the continuing success of your partnership. Charlie speaks from experience. Tyler Elementary School has had four new principals since he began heading Akin Gump's school partnership team.

According to Charlie Johnson, the key to a smooth transition is communication, communication, communication. He also stresses the importance of responding to the vision and priorities of the new principal, and he emphasizes the importance of being willing to modify your partnership activities. For example, even though tutoring has been the centerpiece of Akin Gump's partnership with Tyler Elementary School, during this school year, the emphasis will be on enrichment activities, such as book clubs and Scrabble.

Jennifer Frentress, Tyler's immediate past principal, helped to facilitate the recent transition which was a great help. While it is not always possible to involve the departing principal in a transition, teachers and counselors who are remaining at your partner school can inform the new principal about the school partnership. Check with your continuing school contacts, and make sure they give the new principal a heads-up about your partnership.

Minimizing Travel Time Between Firms and Schools

Transportation, or getting to and from partner schools as efficiently as possible, has been a challenge for many law firms. They have adopted a variety of approaches to avoid losing time spent waiting for taxicabs near schools. **Akin Gump Strauss Hauer & Feld**, **Drinker Biddle & Reath**, and **Epstein Becker & Green**, for example, provide buses or vans when volunteers go to their partner schools. At some firms, volunteers provide rides in personal cars.

Crowell & Moring has eliminated the time required to travel to the firm's partner school by providing a bus to bring children from Plummer Elementary School to the firm for tutoring. This approach not only makes it easier to recruit tutors, it also gives students, who have rarely been beyond the areas near their school and neighborhood, an opportunity to experience a new environment.

Some firms have occasionally used an hourly car rental service that has a pick-up and drop-off location near the firm. Zipcar (www.zipcar.com/dc), the most well-known, requires users to join. This involves a membership fee of about \$25 and a choice of either yearly or monthly dues. The hourly rate of about \$8 per hour includes gas, insurance and free mileage. Hertz (http://www.hertz247.com/Washington) also has an hourly rental service.

Partner Schools' Students Create Holiday Cards

Attorneys and staff at **Dickstein Shapiro** will soon be deciding which student-created design will become the firm's 2013 holiday card. They will choose from some 100 drawings submitted by Visual Arts students at their partner school, Ellington School of the Arts.

The drawings will line the walls of Dickstein's largest conference room where all employees who work at the firm's Washington office will have the opportunity to vote for the winning entries. Their votes, as well as those of Dickstein employees who work in the firm's other five offices, will determine the first-, second-, and thirdplace winners.

Last fall, Ellington's principal, Rory Pullens, happened to visit Dickstein's Los Angeles offices when employees there were voting on the card design. According to him, the competition provides a wonderful opportunity for all participating students, whether or not they are chosen as winners. Prizes will be awarded to the winners at a December reception, and a donation will be made to Ellington's Visual Art Department. The winning design will appear on over 20,000 holiday cards that the firm will mail out in December. It will also be turned into an electronic card that is sent to thousands more and displayed on the firm's website.

Dickstein's 2013 holiday card will be the firm's 16th card designed by an Ellington student. Twelfthgrader, Adela Gutierrez won the 2012 competition for her Holly Berry design. She is now on a full scholarship at Syracuse University where she is studying design.

Elementary School students also create holiday card designs. **Pepper Hamilton**'s cards, for example are created by students from Stanton Elementary School.

In 2013, the firm's card design competition was won by two students—4th grader, Kaniya Smith and 2nd grader, Marquita Edwards.

Walls began this school year with an additional campus that was once Francis Stevens Education Campus and several hundred new 6th, 7th, and 8th graders. During this school year, the Bridge program will be expanded to include the middle school students.
