
**DECLARATION OF DENNIS CORKERY**

I, Dennis Corkery, declare:

1. I am over the age of eighteen. I have personal knowledge of the facts stated herein, unless otherwise indicated below, and am competent to testify to them.
2. I am Senior Counsel at the Washington Lawyers' Committee for Civil Rights and Urban Affairs.
3. On January 4, 2023, I accompanied Mr. Ghebrebrhan to the Office of Tax Revenue (OTR) to request that OTR remove any outstanding quarterly vending fees that were charged after the expiration of his street vending license. The OTR representative provided us with an email contact to assist in this removal process.
4. On January 5, 2023, I emailed OTR on behalf of Mr. Ghebrebrhan to request removal of any outstanding quarterly vending fees post-dating the expiration of his license. Ex. A.
5. To date, I have not received a response from OTR in regards to Mr. Ghebrebrhan's request to have these outstanding fees removed.

I declare under penalty of perjury that the foregoing is true and correct.
