"The DC Gang Database is an unreliable surveillance tool for Black and Brown communities. Now a new proposal expands police powers to stop, frisk, and arrest people in the database just for entering "drug-free zones." The DC Council should reject this kind of unconstitutional policing."

"More than 60 years after Martin Luther King, Jr. gave his "I Have a Dream" speech and the FBI placed him on a watchlist, MPD uses the same type of unreliable policing in the name of the DC Gang Database to targets, label, and detain Black people without due process."

"The District's gang database is stop and frisk policing with a twist that swallows entire families and neighborhoods. In certain predominantly Black or Brown communities, you or I could be included in the gang database because we are friends with someone deemed a gang member6 or your cousin is in the system. Later, MPD passes around your name and photo as a 'gang associate' so that your next encounter with law enforcement becomes a pretext to stop, pat down or chase you."

"Teenagers signal their loyalty to their clique by sitting together at school, hanging out after class, dressing alike, and giving themselves nicknames and symbols. For most kids, these behaviors are considered normal and even encouraged for health social engagement. For Black youth, these behaviors earn them the label of "gang" or "crew" and put them at risk of arrest – just for being in the group."

"MPD's gang database is an appalling example of systemic racial profiling and the over-policing of Black and brown communities in D.C. MPD's criteria for inclusion in the database are disturbingly vague and broad, allowing inclusion based on attire, family connections, or unreliable informants. With little to no oversight, the gang database leads to unwarranted surveillance, overly-aggressive policing, and even dire immigration consequences—all based on dubious and unverified data. This practice undermines trust in law enforcement and violates basic civil liberties without any form of accountability."

"The DC Gang Database is a racist tool that criminalizes Black and Latinx communities for what they look like, where they live, and who they 'associate' with. Because DC shares information on the database with immigration enforcement agencies, they are placing DC's immigrant community at heightened risk of detention and deportation as a result of racially discriminatory and biased policing. We call on the DC government to immediately dismantle the DC Gang Database."

"As is true of every aspect of our criminal legal system, surveillance as a tool for social control originates with this country's brutal commitment to chattel slavery. Over time, the overt justifications offered by law enforcement for surveilling Black and Brown people have shifted, but the purpose and utility have remained the same. Government surveillance is a powerful means of blocking political mobilization, destroying a community's sense of safety and solidarity, and crushing dissent. This is exactly how MPD is wielding its gang database against Black and Brown D.C. residents, especially those living in public and affordable housing. MPD's own records show that people are being added to the database just for speaking to their neighbors in public. This is unacceptable. The D.C. Council must intervene to protect D.C. residents' freedom of association, give relief to people who have been harmed, and abolish the database."
